2018 MY BROTHER VINNY/VINCENT MIRITELLO WALK RELEASE AND WAIVER

In consideration of participating in the **2018 My Brother Vinny/Vincent Miritello Walk (THE WALK)**, I represent that I understand the nature of THE WALK event and that I and/or my minor child am qualified, in good health, and or in proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted over public roads and facilities open to the public during the Activity and upon traffic hazards are to be expected.
